## **Editorial Guidelines for the Conference Papers**

1. The Editorial Committee of the L<sup>th</sup> CONGRESS of the ICMH will provide a fair peer review of the submitted papers.

The Editors will first assess the papers' conformity to these Editorial Guidelines and then ask at least two national/international reviewers to review the papers matching these rules. If the reviewers suggest any modifications/additions/omissions, the author shall implement all these changes to their papers. Upon these changes, if any, approved by the reviewers, the papers will be accepted for publication in the ACTA.

#### 2. File Format:

All the papers shall be delivered in Microsoft Word format saved as .doc; .docx or .rtf.

## 3. Language:

Papers shall be written in English or French - preferably the one in which the paper is to be presented at the Congress. Spelling shall be consistent throughout the paper and spelling and grammar checks shall be used in the language of the paper (British English is preferred for papers submitted in English).

#### 4. Length:

The final written version of the conference paper should be no longer than 50,000 characters (including blanks, footnotes, tables, charts, figures, and appendices). Papers longer than this limit will not be accepted.

## 5. Formatting Guidelines:

The papers should comply with the following guidelines:

- 5.1. Font: Times New Roman: 12 font size in the text including title, abstract, keywords, subheadings, titles of tables/figures/charts/maps/photographs, and bibliography; 10 font size in the footnotes and within the tables/figures/charts etc.
- 5.2. Font Colour: Black (Automatic).
- 5.3. Paper Size: A4.

- **5.4.** Margins: 2.5 cm (top, bottom, left, and right); Binding Margins: 0 cm; Header: 1.25 cm; Footer: 1.25 cm.
- **5.5. TextAlignment:** justified (aligned to the left and right).
- **5.6. Paragraph indentation:** 1 cm hanging indentation in the text including title, abstract, keywords, and bibliography and 0 cm in the footnotes.
- **5.7. Paragraph spacing:** 3 pt before and 3 pt after for all text and footnotes.
- 5.8. Line spacing in the main text: 1.5; Line spacing in footnotes: 1.
- **5.9.** Punctuationmarks(commas,fullstops,exclamationmarks,questionmarks,colon s,and semi-colons), inverted commas, and footnotes numbers shall not be separated by a space from the word preceding them but shall be separated by a space from the word following them.
- **5.10.** The footnote numbers in the body of the paper shall be used adjacent to the punctuation marks or the words to which they are referring without a space and shall be used after the punctuation marks, not before them.

Example:

The footnote number for the sentence should be here<sup>1</sup>. But not here<sup>2</sup>. If the reference is for a word<sup>3</sup> like this, the footnote number may be used like that.

**5.11.** Please do not use page numbering, page breaks, section breaks, hidden characters, and non-breaking spaces.

The Editorial Committee reserves the right to apply formatting to the submitted when necessary.

#### 6. Layout:

The general layout of the papers shall provide the following information in full:

- **6.1. Title:** The article's title in the language of the article (preferably the one in which the paper was presented at the Congress) shall be the first line at the top and centered.
- **6.2.** Name of the author(s): Author(s)full name and surname (only surname in CAPITAL LETTERS) shall be given under the title of the article and centered. The author's/authors' title, place of duty/work or institution affiliated, nationality, corresponding e-mail address, and ORCID number shall be provided with an asterisk footnote (\*) given next to the surname of the author(s). Other explanations regarding the paper or the author(s) (if the paper is a part of a research project or thesis / if the paper is financially supported / if the author(s)

want to thank for important contributions to the paper) shall shortly be added to this footnote.

## 6.3. AbstractandKeywords: Anabstractof200-

250wordsandfivekeywordsshallbe provided before the main text of the paper.

The abstract shall include the purpose, method, hypothesis/question, and findings of the article and present the conclusion reached in the article shortly.

**6.4.** Body of text: The papers shall have the following subsections: Introduction, Subheadings in two levels (if any) (First level section heading should be in **bold** and second level section heading should be in **bold italics**), Conclusion, Bibliography, appendixes (if any), and curriculum vitae of the author.

## 7. Tables, Figures, Charts, Maps, Photographs, etc.:

Tables, figures, and charts (including graphics) shall be presented in the body of the paper where they are supposed to be published. They shall be numbered in their own order (Table 1, Table 2, Figure 1, Figure 3, etc.) and cited consecutively in the text (if citing/referencing is necessary, these citations shall be given in a footnote in consistency with the whole paper). Their numbers and introductory titles regarding the content shall be given at the top of the table, figure or chart centered.

Maps and photographs (including illustrations) may be presented as appendixes at the end of the paper. They shall be numbered in order with numbers and introductory titles regarding the content given at the top centered and in consistency.

#### 8. Quotations:

**Short quotations** in the text shall be shown with double quotes ("..") and **quotations with more than three lines** shall be written as a new paragraph as an inward-aligned paragraph with double quotes ("..."). Quotations within quotations shall be shown with a single quote ("..."). All quotations shall be cited/referenced with a footnote in consistency with the whole paper.

The words to be emphasized within the text shall not be written in bold, italic or underlined but shall be □ritten □ith double quotes ("...").

#### 9. Abbreviations and Acronyms:

Any abbreviation or acronym shall appear in full on its first appearance in the text, followed by the abbreviation or acronym in parentheses, i.e., International Journal of Military History and Historiography (IJMH). The shortened version in abbreviation or acronym may be used thereafter.

Commonly used abbreviations such as e.g., i.e., etc., may be used in the main body of the paper, but they shall be used consistently throughout the whole text. If lesser-known abbreviations are needed to be used, then they shall be explained when first used.

#### 10. Numerals, Dates, and Times, etc:

Please use **Arabic numerals** for all numbers, dates, times, etc. Roman numerals are only allowed in the references/citations of the archival sources (in footnotes and bibliography) in their original archive formats.

The **numerals** shall be written with a comma as a thousand separator and with a period as a decimal separator, e.g.: 12,375,250.25.

The **dates** shall be written in 'Day Month Year' format only, e.g.: 10 November 1938 but not November 10, 1938.

When writing dates, please use words in case of months, not numerals, e.g.: 14 June 1948 but not 14.07.1948.

If different calendars (other than Gregorian one) are to be used, they shall be given together with the Gregorian calendar in parentheses next to them.

Times shall be written in 24-hour format as "Hour:Minute", e.g.: 14:30.

#### 11. Citing/Referencing Style:

The papers shall use the Chicago Manual Style (notes and bibliography), of which the detailed information is provided below. APA Style (in-text parenthesis) shall not be accepted.

#### 12. Footnotes:

References in the papers shall be given in the footnotes and the footnotes should be numbered continuously, starting from 1.

Bibliographic references in the footnotes shall be given **in full upon the first mention**. If the same reference is **to be repeated**, it **may be shortened** to include the surname of the author, the name of the book/article just enough to remind the readers of the full title, and the page number. (See the examples given below).

Other than these shortened references, **please do not use abbreviations** such as Ibid., ibidem, idem, eadem, op. cit. etc.

The following bibliographic descriptions shall be used in the footnotes:

#### 12.1. Archive Documents:

The names of archives, libraries, depositories, classification names, titles of the documents, file numbers and dates of the documents shall be provided in the original language.

#### 12.4. E-books:

E-books are generally referenced in the same way as other books, so please refer to the

appropriate section of this guide.

Please provide information on the format of the resource near the end, such as "Kindle edition" or "website's URL".

Please include a DOI (Direct Object Identifier), if any, or a URL for the online e-books. When there is a choice between using a DOI or a URL, it is recommended that a DOI be used.

If the e-book has no page numbers, use other identifying information for the text you are citing, as per *The Chicago Manual of Style*, 17th ed.: "Electronic sources do not always include page numbers (and some that do include them repaginate according to user- defined text size). For such unpaginated works, it may be appropriate in a note to include a chapter or paragraph number (if available), a section heading, or a descriptive phrase that follows the organizational divisions of the work. In citations of shorter electronic works presented as a single, searchable document, such locators may be unnecessary."

**Note:** Long URL or DOI may also be left undivided if the author chooses to do so. When the footnote includes a URL or DOI that needed to be divided between two lines, please break it after a colon or a double slash or before a tilde (~), period, single slash, comma, or hyphen.

**Note:** Cite specific pages in footnotes, while including the page range for the article in the bibliography.

Both the original source and secondary source shall be cited per their types of references (whether they are books, articles, chapters, or dissertations, etc.) so please refer to the appropriate section of this guide.

In this case, both the original and the secondary sources shall be listed in the footnote and the bibliography.

## 12.11. Forthcoming or In-Press Works:

If the author cites/refers to a work, which is yet to be published, this shall be pointed out by writing "forthcoming" or "in-press" next to the publisher's name or the name of the journal.

If the work in question is accepted for publication but its page numbers, Journal issue, and date of publication are yet to be determined, the term "forthcoming" shall be used.

If it is accepted for publication and its page numbers, Journal issue etc. are determined but yet to be published, then the term "in-press" shall be used.

These works in question shall be cited/referred to per their types of references (whether they are books, articles, chapters, or dissertations, etc.) so please refer to the appropriate section of this guide.

## 13. Bibliography:

The bibliography shall be divided into sections as follows:

#### **Archival Sources/Documents**

#### **Published Works**

#### Internet/Online Sources

#### **Others**

**Note:** Published Works include books, articles, chapters, e-books, theses, and dissertations, while Internet/Online Sources consist of websites.

Resources shall be **sorted alphabetically** in each section (See at the end of this section for the full bibliography example).

The entries of the bibliography shall be written by **putting the surname of the author first (IN CAPITAL LETTERS)** and then the name of the author; then all the other information of the sources shall be included as done in the references.

The author's surname and name shall in the rule be presented in full. (The initials for the names are only permissible if they are given so in the original work.)

For **repeated authors**, full names and surnames shall be used; **no dashes** shall be used. For the titles of the works, books, articles, etc, capitalisation of the titles shall follow the original work, whether it is in headline style or sentence style.

For archives, books, e-books, magazine or newspaper articles, theses or dissertations, websites, etc., the page numbers shall not be used in the bibliography.

For articles or chapters in books, basic journal articles, and journal articles from an online publication, page ranges shall be given in the bibliography.

#### 13.1. Archive Documents:

The names of archives, libraries, depositories, classification names, titles of the documents, file numbers and dates of the documents shall be provided in the original language.

In this case, both the original and the secondary sources shall be listed in the footnote and the bibliography.
